Re: Health Warrior Internet Resale Policy

Dear Valued Customer and Retailer:

Health Warrior strives to build a market for its products through product innovation, consumer education, excellent customer service and promotions that are consistent with our corporate branding policy. Health Warrior will continue to invest significantly to advertise, promote and market its products in all channels, which directly supports your efforts to sell our products.

In an effort to further these efforts and protect Health Warrior's significant investment in its brand, we are implementing the following Internet Resale Policy (the "Policy"), which applies to the resale of Health Warrior's products (the "Goods") in certain internet channels. Failure to comply with the terms of this Policy will result in immediate termination or suspension of Customer's account.

### **Customer's Resale of Goods**

- a. Customer is prohibited from offering, listing or selling any Goods on or to any third party online marketplace or otherwise participate in any offering of the Goods to such online marketplace, including but not limited to Amazon.com, Jet.com, Walmart.com, Ebay.com, Google.com, Target.com and/or Costco.com, without the prior written consent of Health Warrior.
- b. If Customer is a wholesaler: Customer has represented to Health Warrior that it is a wholesaler that sells goods to other wholesalers and to retailers. Customer will not knowingly sell Goods to a retailer in excess of its retail needs so that the retailer may transfer excess goods to another retailer.
- c. If Customer is a retailer: Customer has represented to Health Warrior that it is a retailer and that it will resell Goods only at retail through its retail establishments and associated retailer-branded website(s).
